

1. ADVERSE EFFECTS TO SIGNIFICANT REGIONAL RESOURCES AND FACILITIES IDENTIFIED IN THE STRATEGIC REGIONAL POLICY PLAN

The subject property is not located within one-half mile of the Regional Road Network identified and mapped in the North Central Florida Strategic Regional Policy Plan. Therefore, no adverse impacts are anticipated to the Regional Road Network.

The subject property is located within an Area of High Recharge Potential to the Floridan Aquifer, a Natural Resource of Regional Significance as identified and mapped in the North Central Florida Strategic Regional Policy Plan. Nevertheless, significant adverse impacts are not anticipated to occur as a result of the amendment as the City Comprehensive Plan has adequate policy direction to mitigate adverse impacts to the Floridan Aquifer in a manner consistent with the goals and policies of the North Central Florida Strategic Regional Policy Plan.



EXCERPTS FROM THE CITY COMPREHENSIVE PLAN AMENDMENT

As stated in this report, all properties adjacent to the subject property (including the subject property itself) either have existing or past mining activity and therefore, it is the predominant land use activity in the area. In addition, hundreds of acres to the west and north of the subject property currently have the same Mining future land use designation as proposed on the subject property, as indicated on the future land use map exhibit below:



As such, the proposed Mining future land use designation on the subject property is consistent with the City of Newberry's adopted Comprehensive Plan future land use map and the subsequent pattern of existing land uses.

The proposed Comprehensive Plan future land use map change from County Rural/Agriculture to City Mining is also consistent with the applicable policies in the City of Newberry Comprehensive Plan, as indicated below:

Almost all of the abutting properties in all directions (and including the subject property) have either been part of a historic mining operation or is currently part of an existing, FDEP-permitted mining operation.

The existing shows the land uses within the immediate area:



Mining operations have been a part of the local Newberry economy for generations and as can be seen above, still is a major contributor by providing local jobs, materials for development/construction and contributions to the tax base. The change in the future land use designation to Mining will allow for the entirety of the subject property to again be utilized for mining operations (along with the existing permitted mining onsite), provided that all local permitting (Special Use Permit) and FDEP mining permit is secured subsequent to this map change. In addition, the proposed map change to Mining will be very consistent with the existing land use pattern in the immediate area.

Consistency with Comprehensive Plan

The City of Newberry Comprehensive Plan includes policies related to mining activities. Mining activities involve the extraction of raw materials from the earth in the rural/undeveloped areas of the city. As such, the appropriate future land use designation for lands in the rural/undeveloped area where these resources are located and are available and are proposed for extraction is Mining (as seen in this application request) and therefore, is consistent with the Comprehensive Plan.





Project Narrative - Cross City CDBG-MIT#IR028

The Town of Cross City was awarded \$994,622.59 in CDBG-MIT funds to increase drainage capacity in two low-lying housing authority neighborhoods. Heavy rains during Hurricane Irma caused significant flooding to two neighborhoods as well as road damage. The project will include installing curb inlets and drainage pipes and repairing damaged roads. The roadways that are being repaired run into or adjacent to the Northwest Florida Housing Authority. The first neighborhood includes NE 147th Street and NE 207th Avenue. The second neighborhood includes NE 106th Street and NE 226th Avenue. Construction is estimated to begin within 14 months of execution and completed in an estimated 4 months.
