

The new requirements specify that the agency regulatory plan must include statements concerning laws enacted or amended during the previous 12 months related to rulemaking responsibilities, laws expected to be implemented by rulemaking prior to July 1 of the succeeding year, whether the agency desires to update the regulatory plan for the previous year, and that the agency officials with rulemaking authority have reviewed the plan and existing agency rules and whether existing rules are consistent with the rulemaking authority agency.

Agency Certification of Minor Rule Violation

RECOMMENDATION:

Approve the Agency Minor Rule Certification and authorize the Chair, Executive Director and Council Attorney to sign the letter to the Rules Ombudsman in the Executive Office of the Governor, the President of the Senate, the Speaker of the House of Representatives and the Joint Administrative Procedures Committee certifying that none of the Council's rules qualify for minor rule violation designation.

BACKGROUND:

Pursuant to Section 120.695(2) Florida Statues, as amended by Section 6, Chapter 2016-119 Laws of Florida, each agency shall review all of its rules and designate those for which a violation would be a minor violation and for which a notice of noncompliance must be the first enforcement action taken against a person or business subject to regulation. A violation of a rule is a minor violation if it does not result in economic or physical harm to a person or adversely affect public health, safety, or welfare or create a significant threat of such harm.

In addition, no later than June 30, 2017, and after such date within three months after any request of the Rules Ombudsman in the Executive Office of the Governor, each agency shall review its rules and certify to the President of the Senate, the Speaker of the House of Representatives, the Joint Administrative Procedures Committee and the Rules Ombudsman in the Executive Office of the Governor those rules that have been designated as rules the violation of which would be a minor violation.

The Council has only two agency rules adopted pursuant to Chapter 120, Florida Statutes. The two rules are Rule 29C-8 Regional Dispute Resolution Process and Rule 29C-9 North Central Florida Strategic Regional Policy Plan. Since neither of these rules include any enforcement action related to a violation of the rules, the Council does not have any adopted rules that qualify for minor rule violation designation.
