

I. INVOCATION

Chair Fletcher Hope noting a quorum being present called the meeting to order at 7:02 p.m. Chair Hope gave the invocation.

II. PLEDGE OF ALLEGIANCE

The Council and guests pledged allegiance to the flag of the United States of America.

III. INTRODUCTIONS

Chair Hope welcomed Jonathan Jenkins, County Manager, Dixie County; Paul Martin, Citizen, Dixie County; and Stew Lilker, Columbia County Observer.

IV. APPROVAL OF CONSENT AGENDA

Chair Hope asked that the consent agenda be approved.

ACTION: Commissioner Alford made the motion, with a second by Commissioner Perkins, to approve the consent agenda. The motion carried unanimously.

V. APPROVAL OF REGULAR AGENDA

Chair Hope asked that the regular agenda be approved.

ACTION: Vice-Mayor Bouie Hutchinson made the motion, with a second by Commissioner Adams, to approve the regular agenda. The motion carried unanimously.

VI. GUEST SPEAKER - Sheridan Morby, Senior Research Economist Florida Chamber Foundation

Scott Koons, Executive Director, introduced Sheridan Morby, Senior Research Economist, Florida Chamber Foundation. Ms. Morby made a presentation concerning the Florida Chamber Foundation, and economic trends in Florida and the north central Florida region. Chair Hope thanked Ms. Morby for her presentation.

VII. CHAIR REPORT

Chair Hope welcomed the following new member to the Council.

- ACTION: Commissioner Demps made the motion, with a second by Commissioner Alford, to approve a Resolution of Appreciation for former Council member, Byron Poore, City of Madison. The motion carried unanimously.
- C. Middle and Lower Suwannee River and Withlacoochee River Task Force Appointment
- ACTION: Commissioner Alford made the motion, with a second by Commissioner Rick Davis, to ratify the appointment by the Chair of Commissioner Melissa McNeal, Union County to the Middle and Lower Suwannee River and Withlacoochee River Task Force. The motion carried unanimously.

Commissioner Rick Davis, Chair, Middle and Lower Suwannee River and Withlacoochee River Task Force provided an update concerning Task Force activities. He reported that he and Scott Koons, Executive Director, will be meeting with City of Valdosta officials to receive an update concerning wastewater system improvements by the City.

VIII. COMMITTEE REPORT

- A. Executive Committee -
 - 1. Proclamation Proclaiming April 2025 County Government Month

Chair Hope stated that the Executive Committee recommends that the Council adopt a proclamation proclaiming April 2025 as County Government Month in the north central Florida region. He further stated that County Government Month is celebrated each April by counties across the country to raise public awareness and understanding about the roles and responsibilities of county government.

- ACTION: Vice-Mayor Bouie Hutchinson made the motion, with a second by Councilwoman Hawkins, to adopt the proclamation proclaiming April 2025 as County Government Month, which has been attached hereto and made a part of these minutes. The motion carried unanimously.
 - 2. Proclamation Proclaiming April 2025 Springs Protection Awareness Month

Chair Hope stated that the Executive Committee recommends that the Council adopt a proclamation proclaiming April 2025 as Springs Protection Awareness Month in the north central Florida region. He further stated that Springs Protection Awareness Month is a month-long outreach initiative by water management districts to bring attention and awareness to one of Florida's most critical ecosystems and what is being done to protect them.

ACTION: Commissioner Perkins made the motion, with a second by Commissioner Alford, to adopt the proclamation proclaiming April 2025 as Springs Protection Awareness Month, which has been attached hereto and made a part of these minutes. The motion carried unanimously.

3. Proclamation Proclaiming April 2025 Water Conservation Month

Chair Hope stated that the Executive Committee recommends that the Council adopt a proclamation proclaiming April 2025 as Water Conservation Month in the north central Florida region. He further stated that, during Water Conservation Month each April, water management districts join with local governments to raise awareness about the importance of water conservation and the ways we can reduce our water use all year long.

- ACTION: Commissioner Demps made the motion, with a second by Commissioner Perkins, to adopt the proclamation proclaiming April 2025 as Water Conservation Month, which has been attached hereto and made a part of these minutes.

 The motion carried unanimously.
 - 4. Proclamation Proclaiming April 21-25, 2025 Community Development Week

Chair Hope stated that the Executive Committee recommends that the Council adopt a proclamation proclaiming April 21-25, 2025 as Community Development Week in the north central Florida region. He further stated that Community Development Week is to bring attention to the Community Development Block Grant Program and the HOME Investment Partnerships Program.

- ACTION: Commissioner Perkins made the motion, with a second by Vice-Mayor Bouie Hutchinson, to adopt the proclamation proclaiming April 21-25, 2025 as Community Development Week, which has been attached hereto and made a part of these minutes. The motion carried unanimously.
 - 5. Resolution No. 2025-13 Concerning Senate Bill 1264 and House Bill 1125

Chair Hope stated that the Executive Committee recommends that the Council adopt Resolution No. 2025-13 Concerning Senate Bill 1264 and House Bill 1125.

- ACTION: Commissioner Perkins made the motion, with a second by Commissioner Demps, to adopt Resolution No. 2025-13 Concerning Senate Bill 1264 and House Bill 1125. The motion carried unanimously.
- B. Clearinghouse Committee Committee Level Comprehensive Plan Review Items

Vice-Mayor Bouie Hutchinson, Chair of the Clearinghouse Committee, reported that the Clearinghouse Committee met in person and virtually via communications media technology earlier in the evening and reviewed the following local government comprehensive plan amendments which were included on the Council agenda for consideration.

- #63 City of Gainesville Comprehensive Plan Adopted Amendment (FC No. 24-2ESR)
- #64 Taylor County Comprehensive Plan Adopted Amendment (FC No. 25-1ESR)

Vice-Mayor Bouie Hutchinson stated with regards to these items, the Committee found that the local government comprehensive plans, as amended, were not anticipated to result in significant adverse impacts to regional facilities, Natural Resources of Regional Significance or adjacent local governments. She stated that the Committee recommends forwarding these findings to the respective local governments and FloridaCommerce.

ACTION:

Vice-Mayor Bouie Hutchinson made the motion, with a second by Commissioner Demps, to approve the Clearinghouse Committee recommendations concerning Item #63 - City of Gainesville Comprehensive Plan Adopted Amendment (FC No. 24-2ESR; and Item #64 - Taylor County Comprehensive Plan Draft Amendment (FC No. 25-1ESR. The motion carried unanimously.

C. Program Committee - 2025-26 Overall Program Design

Commissioner Alford, Vice-Chair of the Council and Program Committee Chair, gave the Program Committee Report. She reported that the Program Committee met in person and virtually via communications media technology earlier in the evening to review a draft of the Overall Program Design for the coming year. Commissioner Alford stated that this document is to be used as a basis for the development of a budget and is also to give instruction to staff as to the work which is to be done during the next year. She noted that there are no changes proposed in the Overall Program Design which include new programs not previously discussed and/or approved by the Council. Finally, Commissioner Alford stated the Committee anticipates recommending the Overall Program Design to the Council for adoption at the May 22, 2025 Council meeting.

IX. EX-OFFICIO MEMBER REPORTS

Kathryn Craver, Outreach/Communications Director, Florida Department of Environmental Protection, Northeast District, reported that the Northeast District will conduct Navigating the Permitting and Compliance Process Workshop concerning environmental resource permits on April 30, 2025 at 10:00 a.m. at the Northeast District Office in Jacksonville.

Pamela Gruver, Land Use Planning Supervisor, Office of Conservation Planning Services, Florida Fish and Wildlife Conservation Commission, discussed the Commission's landowner assistance program and land use planning program that address wildlife habitat protection and species conservation.

Ben Glass, Administration Office Chief, Suwannee River Water Management District, thanked the Council for adopting proclamations proclaiming April 2025 as Springs Protection Awareness Month and April 2025 Water Conservation Month.

X. PUBLIC COMMENTS - None

XI. EXECUTIVE DIRECTOR REPORT

A. Florida Regional Councils Association Monthly Activity Report

Mr. Koons reported that the Florida Regional Councils Association is the statewide organization of the ten regional planning councils. He stated that the Association strengthens Florida's regional planning councils, partners with government and the business community to enhance regional economic prosperity and improves the consistency and quality of regional planning councils programs to ensure they add value to state, regional and local initiatives. Mr. Koons also stated that the Association strives to accomplish these goals by carrying out the activities listed in the February 2025 activity report included in the Council meeting packet. He reviewed the activities listed in the February 2025 report.

B. Florida Chamber Foundation ScorecardTM

Mr. Koons reported that the Florida Chamber Foundation has developed the Florida ScorecardTM to provide Florida leaders the metrics needed to secure Florida's future. He stated that the Florida Chamber Foundation's objective to developing a 20-year, statewide strategic plan requires a commitment to measuring our current status and progress toward the stated goals of the Six Pillars 20-year Strategic Plan. Mr. Koons noted that the Scorecard reports metrics for each of the following Six Pillars: Talent and Supply Education, Innovation and Economic Development, Infrastructure and Growth Leadership, Business Climate and Competitiveness, Civic and Governance Systems, and Quality of Life and Quality Places. He reviewed the March 2025 ScorecardTM that was included in the Council meeting packet.

C. Legislative Report

Mr. Koons stated the 2025 Legislature Session convened on March 4, 2025 and is scheduled to adjourn on May 2, 2025. Mr. Koons reported on the status of House Bill 1125 concerning regional planning councils and Senate Bill 1264 concerning regional planning councils.

D. North Central Florida Local Emergency Planning Committee Full Scale Hazardous Materials Exercise

Mr. Koons reported that the North Central Florida Local Emergency Planning Committee will be conducting a Full Scale Hazardous Materials Exercise on May 8, 2025 in Suwannee County. He noted that the exercise will consist of a simulated railroad tanker car derailment.

XII. COUNCIL MEMBER ANNOUNCEMENTS -

Commissioner Alford reported that Alachua County is hosting the World Masters Athletics Championships 2025 from March 23, 2025 to March 30, 2025 at the Alachua County Sports and Event Center, and the West End Community Park in Gainesville.

Chair Hope reported that the Florida Department of Environmental Protection has awarded the City of Archer a \$13 million grant for construction of the City Wastewater System Phase 1.

XIII. NEXT MEETING

Chair Hope stated that the next Council meeting is scheduled to be held on April 24, 2025.

RESOLUTION NO. 2025-13

A RESOLUTION OF THE NORTH CENTRAL FLORIDA REGIONAL PLANNING COUNCIL; OPPOSING ELIMINATION OF STATUTORY REFERENCES TO REGIONAL PLANNING COUNCILS IN FLORIDA AS PROPOSED IN SENATE BILL 1264 AND HOUSE BILL 1125 OR SIMILAR PROPOSED LEGISLATION

WHEREAS, the North Central Florida Regional Planning Council's 12-county geographical area is comprised of Alachua, Bradford, Columbia, Dixie, Gilchrist, Hamilton, Lafayette, Levy, Madison, Suwannee, Taylor and Union Counties and 40 municipalities with over 604,000 residents; and

WHEREAS, the Council is a multi-purpose regional governmental entity with policy responsibilities in the areas of affordable housing, economic development, emergency preparedness, natural resources and regional transportation; and

WHEREAS, for more than five decades regional planning councils have served the public as Florida's only multipurpose regional entities that coordinate intergovernmental solutions to multijurisdictional issues identified by their member local governments; and

WHEREAS, the 67 counties in the state are divided into ten regional planning councils which perform functions in Economic Development, Transportation, Emergency Preparedness and Local Government Services to the extent and as directed by their member counties, cities, and gubernatorial appointees; and

WHEREAS, regional planning councils bring to Florida federal funds for economic development that would otherwise go to other states; and

WHEREAS, regional planning councils receive no general appropriation for operation from the State and, instead, are supported by Federal grant funds, local dues, local contracts, and State contracts for specific programs implemented on behalf of the State; and

WHEREAS, proposed Senate Bill 1264 and House Bill 1125 would remove all references to regional planning councils from Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED, by the North Central Florida Regional Planning Council that:

Section 1. The Legislature is urged to remove all references to regional planning councils from Senate Bill 1264 and House Bill 1125 or any similar proposed legislation; and

Section 2. This resolution shall take effect upon adoption.

BACKGROUND:

The Florida Department of Economic Opportunity has awarded a \$1.499 million Rebuild Florida Community Development Block Grant General Planning Support Program grant to the East Central Florida Regional Planning Council to complete a Regional Joint Mitigation Resiliency Project.

The East Central Florida Regional Planning Council has entered into interagency agreements with the regional planning councils that have counties that were declared federal disaster areas as a result of Hurricane Irma to assist in completing the project. These regional planning councils include Central Florida Regional Planning Council, Northeast Florida Regional Council, North Central Florida Regional Planning Council, Tampa Bay Regional Planning Council and the Treasure Coast Regional Planning Council.

The regional planning councils are engaging in cross collaboration to provide a seamless network of community partners setting forth a single consistent methodology for vulnerability, risk analysis and assessments with reduced focus on county boundaries in order to identify potential multi-jurisdictional or multi-county solutions. The project fills an identified gap in resilience efforts by focusing on the impacts of flooding hazards to the inland counties in Florida.

The scope of work includes the following activities.

- Future Extreme Rainfall Modeling;
- Mitigation Needs Assessment, Template and Mitigation Priority Areas and Project List;
- Small Area Mitigation Plans;
- Regional Resilience Exposure Tool;
- Interactive Best Practice Application; and
- Stakeholder Engagement.

The Council is being paid a total fixed fee amount of \$237,111.25 over a three-year period by the East Central Florida Regional Planning Council for these services.

Rule 41-2.010 (2) of the Florida Administrative Code allows the selection of Community Transportation Coordinators without competitive acquisition upon the recommendation of the Designated Official Planning Agency. Therefore, the Florida Commission for the Transportation Disadvantaged may designate a governmental entity, such as the Board of County Commissioners of Levy County, Florida as the Community Transportation Coordinator without using a competitive selection process.

The Board of County Commissioners of Levy County, Florida is willing to continue serving as the Community Transportation Coordinator for Levy County. Please find attached a resolution adopted by the Board of County Commissioners of Levy County, Florida concerning designation as the Community Transportation Coordinator.

WHEREAS, as a governmental entity, the Board may provide CTC services and be designated the CTC for Levy County without a competitive acquisition process if the North Central Florida Regional Planning Council (as the Designated Official Planning Agency) determines that approach is in the best interest of the transportation disadvantaged;

WHEREAS, in 2002, the Board created Levy County Transit for the purpose of operating a public transportation system for Levy County residents;

WHEREAS, the Board has the ability to provide the organizational structure needed to administer and operate public transportation;

WHEREAS, the Board is willing to continue to act as the CTC for Levy County for a five year period beginning July 1, 2025, in order to provide transportation services to the transportation disadvantaged population in Levy County.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida that:

- 1. In accordance with Chapter 427, F.S. and Rule 41-2.010(2), F.A.C., the Board requests that the Florida Commission for the Transportation Disadvantaged designate the Board as the CTC for Levy County for a five-year period effective July 1, 2025.
- The Board hereby approves the Memorandum of Agreement with the Commission for the Transportation Disadvantaged and authorizes its Chair, or Vice-Chair in the absence or inability of the Chair, to execute the Memorandum of Agreement on behalf of the Board.





Legislative Report

The 2025 regular Legislature Session convened on March 4, 2025 and is scheduled to adjourn on May 2, 2025. The legislative interim Committee schedule was, as follows:

- Week of December 2-6, 2024 (House)
- Week of December 9-13, 2024 (Senate)
- Week of January 13-17, 2025 (House/Senate)
- Week of January 21-24, 2025 (House/Senate)
- Week of February 3-7, 2025 (House/Senate)
- Week of February 10-14, 2025 (House/Senate)
- Week of February 17-21, 2025 (House/Senate)

The Governor called a Special Legislative Session that began on January 27, 2025. The Special Session was scheduled to address illegal immigration, condominium reform, hurricane recovery and constitutional ballot petition initiative reform. The Senate President and the House of Representatives Speaker called a Special Legislative Session that also began on January 27, 2025 and addressed illegal immigration. The Senate President and the House of Representatives Speaker called another Special Legislative Session that began on February 11, 2025 that also addressed illegal immigration.

REGIONAL PLANNING COUNCILS

Senate Bill 1264 by Senator Collins concerning rural and urban business enterprises; revises the purpose of the Florida Department of Commerce; requires that the statewide emergency shelter plan identify the general location and square footage of special needs shelters by regional planning council regions, as such regions existed on a specified date, during the next five years; revises the purpose of the Targeted Marketing Assistance Program to include businesses in rural or urban areas; and establishes the Research, Innovation, Science, and Engineering Investment Tax Credit Program within the Florida Department of Commerce. Referred to Commerce and Tourism Committee; Finance and Tax Committee; Appropriations Committee on Transportation, Tourism, and Economic Development; and Rules Committee. Withdrawn from Finance and Tax Committee. Passed Commerce and Tourism Committee; and Appropriations Committee on Transportation, Tourism, and Economic Development. This bill is currently in Rules Committee.

House Bill 1125 by Representative Owen concerning regional planning and economic development; revises provisions relating to creation of the Florida Department of Commerce and its powers and duties; establishes the Office of Secure Florida within the Florida Department of Commerce; revises economic policies of state comprehensive plan to promote entrepreneurship from certain business startups; revises composition of statewide advisory board of Florida Small Business Development Center Network; creates Rural Accelerator Program within the Florida Department of Commerce; requires funds to be appropriated from Rural Infrastructure Fund; revises composition requirements of Florida Sports Foundation; revises provisions relating to convention grants program established by Florida Tourism Industry Marketing Corporation; revises provisions relating to use of statewide contracts register and who Florida Small Business Development Center is required to coordinate with regarding such use; authorizes counties and municipalities to enter into agreements to create regional planning entities pursuant to specified law; replaces regional planning councils with the Florida Department of Environmental Protection for purposes of hazardous waste management assessments and facilities; revises provisions relating to local health councils; and revises composition of Affordable Housing Study Commission. Referred to Commerce Committee; State Affairs Committee; Ways and Means Committee; and Budget Committee. This bill is currently in Commerce Committee.

SOUTHERN RAIL COMMISSION

Senate Bill 966 by Senator Davis concerning rapid rail transit compact; authorizes the Governor to execute a rapid rail transit compact with specified states, to join the Southern Rail Commission; and provides the form of the compact. Referred to Transportation Committee; Appropriations Committee on Transportation, Tourism, and Economic Development; and Fiscal Policy Committee.

House Bill 833 by Representatives Hinson and Campbell concerning Rapid Rail Transit Compact; authorizes Governor to execute rapid rail transit compact with specified states, to join Southern Rail Commission; and provides form of compact. Referred to Economic Infrastructure Subcommittee; and Commerce Committee. Passed Economic Infrastructure Subcommittee. This bill is currently in Commerce Committee.
