
We will contact Board members prior to the meeting to ensure a physical quorum will be present and to ensure the meeting room attendance will be below 10.

E. Approval of the June 8, 2020 Minutes

### II. NEW BUSINESS

### A. Bylaws

Ms. Godfrey stated that the Florida Commission for the Transportation Disadvantaged requires the Board to review and approve the Bylaws annually. She said staff is recommending the addition of G. Meetings (12) Public Comment to the Bylaws.

ACTION: Kay Tice moved to approve the Bylaws as amended. Diane Head seconded; motion passed unanimously.

### **B.** Grievance Procedures

Ms. Godfrey stated that the Florida Commission for the Transportation Disadvantaged requires the Board to review and approve the Grievance Procedures annually. She said staff is recommending the addition of G. Meetings (8) Public Comment to the Grievance Procedures.

ACTION: Kay Tice moved to approve the Grievance Procedures as amended. Diane Head seconded; motion passed unanimously.

### C. Trip and Equipment Grant Allocation Methodology

Ms. Godfrey stated that the Florida Commission for the Transportation Disadvantaged is conducting a study to explore changes to the Trip and Equipment Grant allocation methodology within Rule Chapter 41-2.014 Florida Administrative Code. She said the Executive Summary of the draft final report published by the Florida Commission for the Transportation Disadvantaged is included in the meeting materials. She said more information about the study can be found on the Florida Commission for the Transportation Disadvantaged webpage.

Mr. Pearson stated that the proposed changes to the funding formula may reduce the amount of Trip and Equipment Grant funds allocated to Lafayette County. He said Suwannee River Economic Council, Inc. will continue to provide transportation services in Lafayette County no matter what changes are made to the funding formula.

# D. Suwannee River Economic Council, Inc. Operations Reports

Mr. Pearson stated that the COVID-19 pandemic drastically reduced the amount of transportation services Suwannee River Economic Council, Inc. has been able to provide. He said during the April – June reporting period, Suwannee River Economic Council, Inc. only provided critical medical transportation. He said they are slowly getting back to normal service levels.

Ms. Godfrey asked if the reduction in service will affect Suwannee River Economic Council, Inc.'s ability to continue receiving Innovation and Service Development Grant funds.

Mr. Pearson said he expects the Florida Commission for the Transportation Disadvantaged to consider the effects of COVID-19 when awarding future grant funds. He also commended the Florida Department of Transportation for providing financial assistance to all of the Community Transportation Coordinators in order to keep transportation systems running.





# Commission for the Transportation Disadvantaged

# Purpose (427.013 F.S.):

Accomplish the **coordination** of transportation services provided to the transportation disadvantaged.

**Coordination Defined**: Arrangement for the provision of transportation services to the transportation disadvantaged in a manner that is cost-effective, efficient, and reduces fragmentation and duplication of services


# Goal (427.013 F.S.):

To assure the cost-effective provision of transportation by qualified CTCs or transportation operators.



# Commission for the Transportation Disadvantaged

- Duties
  - Develops policies and procedures for the coordination of transportation services for the Transportation Disadvantaged.
  - Designates the planning agency in areas outside the purview of an MPO.
  - Approves the appointment of CTCs.
  - Contract with CTCs.

Designated Official Planning Agency

The Planning Agency assists the Commission at the local level in accomplishing the coordination of transportation services to the transportation disadvantaged.



Designated Official Planning Agency

Planning Agencies are:

- Metropolitan Planning Organizations;
- County/City Governments;
- Regional Planning Councils; or
- Local Planning Organizations who are performing planning activities in designated service areas.

A Planning Agency may be responsible for multiple services areas.

# Duties

- Appoints members to the Local Coordinating Board
- Provides staff to the Local Coordinating Board
  - Quarterly Meetings (Meeting Schedule, Agendas, Minutes, By-Laws, Grievance Procedures, Training)
  - Annual Public Hearing



# Designated Official Planning Agency

# **Duties** (Continued)

- Recommends to the Commission a Community Transportation Coordinator (CTC)
  - Competitive Procurement Process
    - (Local Procurement Process or Chapter 287, F.S.)
  - Memorandum of Agreement between the Commission and CTC
  - CTC designation is for five years
- Evaluates the CTC (Planner & LCB) annually

# **Duties** (Continued)

- Reviews annually the Annual Operating Report prepared by the CTC and submits it to the Local Coordinating Board for approval.
- In coordination with the CTC and the Local Coordinating Board, develops a Transportation Disadvantaged Service Plan (TDSP)



**Local Coordinating Board** 

Purpose

- Identify local service needs
- Provide information, advice and direction to the CTC on the coordination of services to be provided through the Coordinated Transportation System
- Serve as an advisory body to the Commission regarding a particular service area



# **Local Coordinating Board**

# **Coordinating Board Structure**

- Members are appointed by the Planning Agency
  - 1 elected official to serve as Chairperson
  - 1 Vice-Chairperson (elected annually by LCB Members)
  - Additional member groups which compose the LCB

# Coordinating Board Structure (Continued)

# **Local Coordinating Board**

- Duties
   Assists CTC in establishing eligibility guidelines and trip priorities
  - Evaluates CTC annually
  - Reviews and approve Transportation Disadvantaged Service Plan (TDSP) and Memorandum of Agreement (MOA)
  - Appoints Grievance Committee to process and investigate complaints

# Community Transportation Coordinator

# Duties

- Plans, administers, monitors, coordinates, arranges and delivers coordinated Transportation Disadvantaged services originating in their designated service area
  - Operates centralized call center
  - Determines transportation eligibility
  - Schedules trips
  - Performs gatekeeping duties
  - Invoices purchasing agencies



# Community Transportation Coordinator

# Duties (Continued)

- Develops a Transportation Disadvantaged Service Plan with Local Coordinating Board.
- Prepares and submits Annual Operating Report
- Recommends eligibility guidelines and trip prioritization to the Local Coordinating Board for non-sponsored trips.



# Community Transportation Coordinator

Selecting a Community Transportation Coordinator

- Interested organization responds to Planning Agency's request for a Community Transportation Coordinator.
- Planning Agency submits recommendation to the Commission for approval.
- Designation is for 5 years.

# **Purchasing Agency**

- Uses the coordinated transportation system for provision of services to its clients.
- Pays the rates established in the service plan or negotiated statewide contract
- Negotiates with the Commission before procuring transportation disadvantaged services.
- Identifies the specific amount of money they will allocate in their legislative budget request to provide transportation disadvantaged services.

# **Purchasing Agency**

## Duties (Continued)

- Provides the Commission an accounting of all funds spent as well as the number of trips purchased with agency funds.
- Assists communities in developing coordinated transportation systems designed to serve the transportation disadvantaged.
- Ensures that its rules, procedures, guidelines, and directives are conducive to the coordination of transportation funds & services for the transportation disadvantaged.



### Section 112.3143, Florida Statues

- Public officer includes any person serving on an advisory body.
- Board members are considered public officers.
- Board members may not vote on any matter that would be to their special private gain or loss.



### Section 112.3143, Florida Statues

 Board members shall make every reasonable effort to disclose the nature of their interest as a public record in a memorandum filed with staff.

The memorandum shall be incorporated in the meeting minutes.

### Section 112.3143, Florida Statutes

- Board members shall, prior to a vote being taken, publicly state the nature of their interest in the matter from which they are abstaining from voting.
- Within 15 days after the vote occurs, Board members shall disclose the nature of their interest as a public record in a memorandum filed with staff.

### Section 112.3143, Florida Statutes

- No Board member shall participate in any matter which would be to the Board member's special private gain or loss without first disclosing the nature of their interest in the matter.
- In the event that disclosure has not been made prior to the meeting or that any conflict is unknown prior to the meeting, the disclosure shall be made orally at the meeting when it becomes known that a conflict exists.
- A written memorandum disclosing the nature of the conflict shall be filed within 15 days after the oral disclosure.

#### WHO MUST FILE FORM 8B

This form is for use by any person serving at the county, city, or other local level of government on an appointed or elected board, council, commission, authority, or committee. It applies to members of advisory and non-advisory bodies who are presented with a voting conflict of interest under Section 112.3143, Florida Statutes.

Your responsibilities under the law when faced with voting on a measure in which you have a conflict of interest will vary greatly depending on whether you hold an elective or appointive position. For this reason, please pay close attention to the instructions on this form before completing and filing the form.

#### INSTRUCTIONS FOR COMPLIANCE WITH SECTION 112.3143, FLORIDA STATUTES

A person holding elective or appointive county, municipal, or other local public office MUST ABSTAIN from voting on a measure which would inure to his or her special private gain or loss. Each elected or appointed local officer also MUST ABSTAIN from knowingly voting on a measure which would inure to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent, subsidiary, or sibling organization of a principal by which he or she is retained); to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies (CRAs) under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

For purposes of this law, a "relative" includes only the officer's father, mother, son, daughter, husband, wife, brother, sister, father-in-law, mother-in-law, son-in-law, and daughter-in-law. A "business associate" means any person or entity engaged in or carrying on a business enterprise with the officer as a partner, joint venturer, coowner of property, or corporate shareholder (where the shares of the corporation are not listed on any national or regional stock exchange).

#### ELECTED OFFICERS:

In addition to abstaining from voting in the situations described above, you must disclose the conflict:

- PRIOR TO THE VOTE BEING TAKEN by publicly stating to the assembly the nature of your interest in the measure on which you are abstaining from voting; and
- WITHIN 15 DAYS AFTER THE VOTE OCCURS by completing and filing this form with the person responsible for recording the minutes of the meeting, who should incorporate the form in the minutes.

## APPOINTED OFFICERS:

Although you must abstain from voting in the situations described above, you are not prohibited by Section 112.3143 from otherwise participating in these matters. However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.







# 3. Barriers to Coordination

Medicaid non-emergency transportation services are no longer coordinated through Florida's Coordinated Transportation System in Lafayette County. In May 2014, the Florida Agency for Health Care Administration implemented Florida's Managed Medical Care Program. The Managed Medical Care Program requires Managed Medical Assistance Plans to provide transportation to their enrollees who have no other means of transportation available.

The Managed Medical Assistance Plans provide transportation services directly through their own network of transportation providers. According Chapter 2 of the Florida Agency for Health Care Administration Transportation Coverage, Limitations and Reimbursement Handbook, July 1997, "Medicaid is required by Chapter 427, Florida Statues to purchase transportation services through the designated Community Transportation Coordinator, unless those services are not cost effective or the Community Transportation Coordinate Medicaid transportation services."

Other barriers to the coordination of transportation services in Lafayette County include the following:

- low density, rural population limits the ability to multi-load vehicles;
- out-of-county trips are required due to the limited availability of medical services/facilities; and
- various requirements for agency client transportation services.

SREC, Inc. is a non-profit organization chartered in 1964 whose purpose is to provide services to low income and elderly citizens to alleviate poverty. SREC, Inc. is currently the State of Florida designated Community Transportation Coordinator in five (5) rural, North Florida counties including Bradford, Dixie, Gilchrist, Lafayette, and Union counties. A voluntary Board of Directors governs SREC, Inc. The Board employs an Executive Director who has normal CEO responsibilities with the agency and the many programs it administers. SREC, Inc. has four (4) Program Directors providing direct supervision of the ongoing programs, including the Transportation Department.

Organizational structure: As the CTC for five (5) rural counties in North Florida SREC, Inc. operates partial brokerages with all trips provided by SREC, Inc. The exception to this is stretcher services which are contracted to a local government provider. SREC, Inc. provides mainly demand response services and requires 24-hour notice for trip requests. SREC, Inc's Executive Director has direct oversight of the Director of Transportation, who in turn manages the Transportation Department. Currently SREC, Inc. employs approximately 27 employees in the Transportation Department across the five (5) service areas.

To train drivers SREC, Inc. uses the FDOT approved computer testing and training modules, the online substance abuse training provided by CUTR, and personal, handson training provided by CTAA PASS certified trainers employed by SREC, Inc. Administrative aspects of the Transportation Department, including but not limited to fleet inventory and maintenance, driver credentialing, insurance tracking, record keeping, and reporting, are led by the Director of Transportation.

SREC, Inc. currently utilizes a combination of funding sources including Section 5311, Commission for the Transportation Disadvantaged, and Medicaid. However, the funding opportunities through both Medicaid and the CTD have greatly diminished recently. Fully explain your transportation program:

The checklist used by vendors is FDOT approved. General maintenance is performed as needed if the driver reports an issue during the required daily inspection or if the vehicle has a mechanical failure.
- Service route and ridership numbers (See Attachment 1, TDSP)
- SSPP: See Attachment 2, Bus Transit System Annual Safety and Security Certification.
- Drug-free workplace: See Attachment 3, Certificate of Compliant for anti-drug and alcohol misuse prevention program.
- Data collection: SREC, Inc. utilized transit software Parascope by CTS Trip Master Enterprise. The application connects the drivers on the road with the dispatchers in the office, and displays the driver's trip manifest electronically. The trip information is updated in real time and data such as pickup and drop-off odometers and times are captured immediately. Additional data collection and reporting through Parascope includes vehicle mileage and fuel consumption.

Due to the rural nature of Lafayette County trip lengths are increased because of minimal local medical facilities, which in turn creates an increase in the cost of providing those trips. In addition Lafayette County has a high need for trips that are non-medical such as shopping, employment, and job training. However, with local governments providing limited local resources and the extensive reduction in the Transportation Disadvantage Trust Fund, the 5311 program funds fill the gap and allow for transportation services to be provided in rural areas like Lafayette County. Thus, the requested 5311 funding helps offset the cost of the entire transportation system and allows for continued transportation services to be provided to those in need in Lafayette County.

Due to the nature of a rural area like Lafayette County and the need for transportation services to travel over 40 miles to medical facilities, multiple daily trips are required to cover these distances while also trying to balance the needs and physical limitations of the passengers whom we serve. It is imperative to operate the transportation services provided by SREC, Inc. as efficiently and economically as possible while maintaining that balance between business and compassion. SREC, Inc. utilizes the transit software program Parascope from CTS Trip Master Enterprise to electronically and in real time connect the driver on the road with the dispatcher in the office. The program provides data such as pickup and drop-off odometers and times, as well as other important data collection, tracking, and reporting such as vehicle mileage and fuel consumption. Additionally, SREC, Inc. employs a fulltime Transportation Operations Manager and a fully staffed Finance Department. As the reporting regulations in the transportation industry are increasing continually the funding request from Section 5311 will enable SREC, Inc. to continue to operate an efficient transportation program while maintaining a system of detailed recording and reporting in all facets of the transportation operation. If this grant is not fully funded, can you still proceed with your transportation program? Explain.

If the Section 5311 grant is not fully funded as intended SREC, Inc. would continue to operate, but the amount of services available to the residents of Lafayette County would be drastically reduced at the detriment of those who need this service.
