

D. Suwannee River Economic Council, Inc. Operations Reports

Mr. Pearson discussed the quarterly operations reports. He stated that Suwannee River Economic Council, Inc. was not awarded Innovative and Service Development Grant funds for Fiscal Year 2022/23. Therefore, he said Suwannee River Economic Council, Inc. is unable to continue providing student transportation to the Big Bend Technical College. He explained that the loss of this service will reduce total trips and possibly reduce the amount of Transportation Disadvantaged Program funds Lafayette County receives in the future.

1. <u>New Ride</u>: When client calls in for a ride verify through CTS software, to see if a new or existing rider of the system. If new send the rider the TD application, by d be completed. The rider CAN receive (1) ride prior to completion of application.

- 2. <u>Transportation Application (TD)</u>: All TD riders must complete a transportation application form to determine eligibility and the appropriate means of service.
