The Lafayette County Transportation Disadvantaged Coordinating Board will hold a public workshop **Monday, May 10, 2021 at 2:00 p.m.** in the Suwannee River Economic Council, Inc. Senior/Client Services Center located on State Road 27 in Mayo, Florida.


