The Madison County Transportation Disadvantaged Coordinating Board will hold a public workshop Monday, May 3, 2021 at 1:00 p.m. in the meeting room of the Madison County Courthouse Annex located at 229 Pinckney Street, Madison, Florida.

The Centers for Disease Control and Prevention social/physical distancing guidelines will be followed in the meeting room. Wearing of face coverings will be required. 
