PURPOSE: The Metropolitan Transportation Planning Organization for the Gainesville Urbanized Area has scheduled a public meeting to receive input concerning the proposed Transportation Improvement Program for Fiscal Years 2019-20 to 2023-24. The Transportation Improvement Program is a staged implementation program of transportation projects consistent, to the maximum extent feasible, with the Alachua County and City of Gainesville comprehensive plans.

Projects in the proposed Transportation Improvement Program are also consistent with the Gainesville Metropolitan Area Year 2040 Long-Range Transportation Plan. This plan identifies transportation system modifications expected to be needed to serve projected volumes and patterns of traffic through the Year 2040. <u>A final decision regarding all projects contained in the Transportation Improvement Program will</u> be forwarded to the Florida Department of Transportation by the adoption of this Transportation Improvement Program document.

Public notice of public involvement activities and time established for public review and comments on the Transportation Improvement Program will satisfy the Program of Projects.

The Federal Obligations Reports are included in Appendix B of the Transportation Improvement Program. These Reports show the expenditure of federal funds within the Gainesville Metropolitan Area from October 1, 2017 through September 30, 2018.

This map only shows some of the transportation projects scheduled during the next five years. The proposed Transportation Improvement Program includes transportation projects such as: bicycle; pedestrian; project development and environmental studies; resurfacing/ repaving; school safety concern; transportation alternatives; and transit projects, including transportation disadvantaged projects.

STAFF RECOMMENDATION

Amend the Chapter II. Metropolitan Transportation Planning Organization for the Gainesville Urbanized Area Technical Advisory Committee Bylaws D. Membership (item 1) to:

- Remove representation from the City of Gainesville Regional Transit System;
- Add representation from the City of Gainesville Department of Mobility; and
- Consolidate representation from the City of Gainesville Public Works Department and the City of Gainesville Department of Mobility as shown in Exhibit 1.

BACKGROUND

The City of Gainesville has restructured several transportation-related functions into the new Department of Mobility. With this consolidation, the City of Gainesville has requested the following modifications to its representation on the Technical Advisory Committee:

- Removal of representation from the City of Gainesville Regional Transit System;
- Addition of representation from the City of Gainesville Department of Mobility; and
- Consolidation of representation from the City of Gainesville Public Works Department and the City of Gainesville Department of Mobility.

The City of Gainesville Department of Mobility has designated the following representation on the Technical Advisory Committee to be the:

- Transportation Planning Manager (formerly of the Public Works Department) as the primary voting member; and
- Regional Transit System Director as the alternate voting member.

Federal requirements for transit agency representation are maintained through the City of Gainesville Department of Mobility. This change will reduce the Technical Advisory Committee roster from eleven to ten members. Exhibit 2 is a copy of the Technical Advisory Committee roster. Exhibit 3 is the email chain concerning these changes.

Subsequent to the discussion, the Metropolitan Transportation Planning Organization approved a motion to:

Request that the Florida Department of Transportation implement its Context Classification criteria from the Florida Design Manual along this corridor with a focus on:

- Reduction in speed limits;
- Reduction in visual clutter by eliminating some highway signs or collocating signs on poles;
- Provide designated multiple midblock pedestrian crossings along the corridor;
- Increase lighting at median openings and signalized intersections; and
- Provide bus bays;

Or explain why it will not complete these modifications.

At its August 27, 2018 meeting, the Metropolitan Transportation Planning Organization received an update on the scoping of the U.S. Highway 441 resurfacing project. The Florida Department of Transportation is currently coordinating with Alachua County for the implementation of a linear park on the Paynes Prairie corridor. The Florida Department of Transportation intends to follow the elements of the Florida Design Manual 2018 and other criteria specified in the letter.

Good Morning,

At the April 22nd MTPO meeting, commissioner Byerly requested information about the ongoing construction on U.S. 441. The recent work on U.S. 441 south of Williston Road was a maintenance contract. The top one inch of asphalt was failing. In addition to a rough ride, we were receiving numerous complaints of vehicle damage and broken windshields. This contract removed the top 1" of asphalt in those areas where it was failing the worst and replaced it with new asphalt. We were only able to replace about ¼ of the travel lane surface, so it was focused in the areas that were in the worst condition. This was a temporary repair intended to carry us to the mill and resurface project currently under design that will also raise the road surface about 5" and install guardrail across the floor of Paynes Prairie. This project is expected to be awarded in about two years.

Thank you for your letter of April 24, 2019 regarding Interstate 75 and U.S. Highway 441 Traffic and Safety Concerns. I appreciate the concerns expressed in your letter and understand that, in light of the recent accident, there is a heightened concern about the safety of the roadway.

The Department's Traffic Operations Safety Office will be conducting a safety study of Interstate 75 from the Marion County Line to I-10 in Columbia County to determine if any safety improvements are warranted. The study will include the review and analysis of crash data, crash trends and identification of potential countermeasures. Please allow six months for our consultant to complete this work. Once the study is completed, we will inform you of our recommendations.

The Department will also be setting up a meeting with Sherriff Darnell and FHP to discuss investments made to date and to further develop strategies.

Regarding a barrier system along Interstate 74 and US 441 through Paynes Prairie, the Department has projects on Interstate 75 and US 441 currently programmed to install guardrail along these roadways through the prairie. The Interstate 75 project is scheduled to start construction in the Spring of 2020 and the US 441 project is scheduled to start in the Fall of 2020.

Dear Chair Cornell,

The Department has received the Gainesville MTPO's letter dated April 24th, 2019 requesting the Florida Department of Transportation to reevaluate the intersection of SR 121 at NW 30th Place. The project was originally evaluated by request in 2016, and not recommended.

The Traffic Operations review of the MTPO request for left turn lanes on SR 121, from NW 16th Ave. to US 441, did not recommend a turn lane at this location. The study determined that there are two sections of boardwalk on the west side of the roadway- the first section runs from north of NW 21st Place to NW 24th Avenue and the second section runs from NW 30th Place to south of NW 33rd Lane. Due to the complexity of the boardwalk systems, widening within these limits would require acquisition of Right of Way.

The Department currently has a funded project on SR 121 to add two-way center left turn lanes from NW 16th Ave, to US 441 in various locations, complete sidewalk gaps and add signage (439490-1). The project lets in July 2020.
