<u>Technical Advisory Committee (TAC)</u> - Local and state planners, engineers, transit operators and other technical representatives who provide technical input regarding transportation plans and programs and make recommendations to the MTPO.

<u>Transit Development Plan (TDP)</u> - This is a short-range plan which profiles existing and future demand for transit (bus) service, analyzes current bus routes and establishes a five-year plan for bus service. The MTPO staff provides the staff support necessary for the development of the annual TDP. A current and up-to-date TDP is required for the receipt of federal and state financial assistance.

<u>Transportation Disadvantaged (TD)</u> - Refers to those persons who, because of physical or mental disability, income status, or age or who for other reasons, are unable to transport themselves or purchase transportation.

Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy For Users (SAFETEA-LU) - A federal act established to develop a national intermodal transportation system which is economically efficient and environmentally sound, encourages citizen participation, provides the foundation for the nation to compete in a global economy, and will move people and goods in an energy efficient manner.

DEFINITIONS/ACRONYMS

<u>Bicycle/Pedestrian Advisory Board (B/PAB)</u> - Citizen volunteers who provide input to proposed bicycle and pedestrian transportation planning and programming and also make recommendations to the MTPO.

<u>Citizens Advisory Committee (CAC)</u> - Citizen volunteers who provide input to proposed transportation plans and programs, provide input to proposed transit transportation plans and programs and also make recommendations to the MTPO.

<u>Congestion Management System (CMS)</u> - A systematic process that provides information on transportation system performance and alternative strategies to alleviate congestion and enhance the mobility of persons and goods.

<u>Florida Department of Transportation (FDOT)</u> - State agency granted the legislative authority to develop and maintain State transportation facilities and services.

<u>Intermodal</u> - Moving people and goods using various combinations of transportation modes (transit, rail, automobile, truck, bicycle, etc...).

<u>Long-Range Transportation Plan (LRTP)</u> - A transportation plan which provides guidance in the development of an efficient transportation system over a period of 20 years.

<u>Metropolitan Transportation Planning Organization (MTPO)</u> - An agency created under federal and state law to provide a forum for cooperative decision-making in regard to regional transportation issues. Voting membership includes the Mayor and six City of Gainesville Commissioners and the five Alachua County Commissioners.

<u>Multimodal Transportation System</u> - A comprehensive transportation system including the following options: auto, bus, truck, motorcycle, bicycle, pedestrian and transit.

<u>Project Development & Environmental Study (PD&E)</u> - A study performed to determine the feasibility of a road improvement by identifying possible alternatives and evaluating the social, economic and environmental impacts associated with each alternative.

INTRODUCTION

How can YOU influence the future of transportation?

In the Gainesville Metropolitan Area, a well-designed efficient, effective and livable transportation system is critical to the mobility of the region, the viability of the community, and ultimately the economy. Transportation is more than roads. Transportation affects our quality of life and provides a link for our essential needs (food, medical assistance, etc.). As the basic structure of our community's public space, our transportation system affects us in many ways, both as users and neighbors. It provides for a variety of transportation alternatives including automobiles, trucks, buses, motorcycles, bicycles and pedestrians. And it defines our neighborhoods and business districts. Because the transportation system is to serve YOU, the people, YOU are encouraged to get involved in the transportation planning process.

Why? Because YOU travel our roads and sit in rush hour traffic, you may have specific travel needs and desires you want to communicate. YOU travel on the transportation system nearly every day and see the need for improvements. YOU also enjoy bicycling and walking and may have ideas for sidewalks and bikeways that you want to share. YOU live in a neighborhood and can see the effect of roads on the quality of life of your community. YOU are an important part of the planning process.

This guide is designed to help YOU gain a better understanding of the transportation planning process and to help YOU get involved and participate in the decision-making process concerning how YOUR transportation funds are spent in this area. This guide also shows who can be contacted for more information and explains some of the technical terms and acronyms used in transportation planning. We want your input -- comments and concerns. YOU have the opportunity to get involved and make a difference in your community.

What is the Metropolitan Transportation Planning Organization or MTPO



A Metropolitan Transportation Planning Organization, more commonly known as an MTPO, is a policy board comprised of locally-elected officials that is required for urbanized areas with a population over 50,000.

The Metropolitan Transportation Planning Organization for the Gainesville Urbanized Area (MTPO) has direct authority over transportation decisions in the Gainesville urbanized area. It is mandated by federal and state legislation and is responsible for establishing a continuing, cooperative and comprehensive transportation planning process.

The MTPO is responsible for making transportation decisions. In other words, planning how to meet short-term and long-term travel needs. As a contributor, you can help the MTPO develop plans which meet the mobility needs of the community and are practical to implement given financial, environmental and social constraints.

Transportation Improvement Program (TIP)

The purpose of the TIP is to identify all transportation projects to be funded over the next five-year period. This document is used to coordinate needed transportation projects with respect to timing, location and source of funding. In Alachua County, there are two different TIP documents. One is prepared and adopted by the MTPO for the Gainesville Urbanized Area, while the other is prepared and adopted by the Alachua County Commission for all of Alachua County. These documents are developed, reviewed and adopted in the Spring of each year.

Unified Planning Work Program (UPWP)

The UPWP identifies the planning efforts to be undertaken by all agencies in the Gainesville Metropolitan Area in order to maintain a comprehensive, cooperative and continuing transportation planning program. This document serves as the program budget for MTPO staff.

MTPO PLANS AND PROGRAMS

Long Range Transportation Plan

A twenty-year transportation plan has been adopted by the MTPO through the year 2025. This Plan identifies major improvements to the transportation system which will be needed in the future to address projected patterns and volumes of traffic. Updates to this plan are prepared and adopted about every five to seven years.

Transit Planning

Transit planning activities include the development of a <u>Transit Development Plan (TDP)</u>. The TDP is a short-range plan, prepared by the Regional Transit System, concerning existing and future demand for transit (bus) service. This plan establishes a five-year plan for bus service. A current and up-to-date TDP is required in order to receive federal and state financial assistance for the Regional Transit System. A transit service evaluation is conducted to coincide with the Long Range Transportation Plan Update.

Bicycle Facility Planning

The MTPO is actively involved in conducting bicycle planning studies. In 2001, the MTPO adopted the <u>Alachua Countywide Bicycle Master Plan</u>. In addition, the MTPO also monitors bicycle activity. This information is reported every five years in a document entitled <u>Bicycle Usage Trends Program Report</u>.

Management Systems - Gainesville Metropolitan Area Mobility Plan

Work continues to implement management systems required for the GMA by the Transportation Equity Act for the 21st Century and SAFETEA-LU. The Mobility Plan serves as the congestion management process for the Gainesville Metropolitan Area. As of 2007, MTPO staff prepares an annual status report on the Mobility Plan strategies. Results of this report are used and incorporated in the development of the <u>Transportation Improvement Program</u>. This will happen primarily through the annual development of transportation priorities that are developed over the summer and forwarded to FDOT annually.



Each year, MTPO staff, working in cooperation with state and local agencies, develops multimodal [automobile, bicycle, pedestrian and transit] information concerning levels of service (traffic congestion) for arterial and collector roads in the Gainesville Metropolitan Area. This information is shared with state and local agencies and is used to support local comprehensive planning activities.

What area does the MTPO cover?



The area of planning responsibility for the MTPO does not include all of Alachua County, but rather the developed and developing portions in and around the City of Gainesville.

How is this transportation planning funded?





Federal funding for highway, transit, bicycle and pedestrian planning is provided by the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA). The Florida Department of Transportation (FDOT) matches these federal funds with both cash and in-kind services. The Alachua County Board of County Commissioners and the Gainesville City Commission provide a local cash match.

Special funding for planning related to the Transportation Disadvantaged is provided through the Florida Commission for the Transportation Disadvantaged. These funds, derived through a fee on motor vehicle registrations, do not require a local match.


